

Terms and Conditions

The following Terms and Conditions (“T&C”) apply to Maserati Campaign offered by Affin Bank Berhad (“AFFIN BANK”).

1. Campaign Eligibility & Period

- 1.1. This campaign is effective from now until 31/12/2021.
- 1.2. All applications must be made within the Campaign Period.
- 1.3. This campaign is NOT APPLICABLE for Hire Purchase-i financing.
- 1.4. This Campaign is opened to all customers of AFFIN BANK (“Eligible Customers”).
- 1.5. Margin of Financing is up to 70% only.
- 1.6. Financing rate is 0% flat per annum is applicable for hire purchase financing tenure of 3,4 and 5 years.
- 1.7. This campaign is valid for financing application of all New Maserati models except for Levante Trofeo invoiced by Naza Italia Sdn. Bhd.
